
Employer Vaccine Mandates What you can do



Don't decline shot

Ask for Informed Consent

- To make a decision you need more information to decide what is best for you.
- Organize others who don't want the shot or those who got one and now don't want another
- DO NOT QUIT



Employer who mandates is legally obligated to answer Q's on Informed Consent

Get your Answers in Writing (email thread)

- Share that FDA approval does NOT relinquish the Employer from their responsibility to fulfill Informed Consent as the arbiter of the mandate.
- Pfizer-BioNTech clinical trial ends May 2, 2023,
- Moderna-NIH clinical trial ends October 27, 2022
- Johnson & Johnson clinical trial ends January 2nd, 2023
- The recently approved Pfizer (Comirnaty) is currently unavailable
- If you have a labor union, changes to CBA without consent violates Contract Law





Or to administer COVID vaccines




MY RIGHT TO MEDICAL PRIVACY

If I get the shot will my right to keep my vaccination status private be honored?




Who is liable if I am injured

Will you - my employer mandating this vaccine compensate me or my family if I am killed?




Will my consent terminate my life insurance policy?


